Appropriation Limitation Code (APPROP-CODE-LIM). This is a three digit code which identifies the type of funding (direct or reimbursable) and the Administrative Target Unit which has the funding.

1. The first digit of the limitation is restricted as follows:

**Operating Expense Appropriation:**

- 1XX = Direct Funds
- 2XX = Direct Funds (pickup accounts)
- 3XX = Direct Funds (HQ "Refund Program")
- 4XX = Industrial Funds
- 8XX = Reimbursable Funds

**Reserve Training Appropriation:**

- 1XX = Direct Funds
- 2XX = Direct Funds (pickup accounts)
- 3XX = Direct Funds (HQ "Refund Program")
- 8XX = Reimbursable Funds

**Acquisition, Construction, and Improvement Appropriation:**

- 0XX = Project - primary responsibility - Commandant (G-E)
- 3XX = Direct Funds (HQ "Refund Program")
- 5XX = Reimbursable Project Funds

**All Other Appropriations:**

- 1XX = Direct Funds
- 2XX = Direct Funds (pickup accounts)
- 3XX = Direct Funds (HQ "Refund Program")
- 8XX = Reimbursable Funds
